## You said, we did ...

Notes from the meeting on 24 November 2010 at Spondon Village hall

You said	Your Neighbourhood Team did
Anti Social behaviour at the Tunnel — identified by the Police as a local hotspot for anti social behaviour near to Arnhem Terrace  Auto crime and Domestic Burglary - What has happened in response to the large number of windscreens damaged around	Police priority. The local Safer Neighbourhood Team have undertaken high visibility patrols around the area and officers will deal positively with individuals committing anti-social behaviour by submitting ASB referrals.  There has been a considerable drop in the calls for service made to the police with regards to anti-social behaviour incidents taking place at Arnhem Terrace Tunnel.  Agreed at the forum meeting to keep Burglary and auto crime as a Police priority. Over the last month there has been a considerable drop in the number of burglaries and auto crime offences reported to the police.  The local Safer Neighbourhood Team continues to undertake overt and covert patrols as part of Operation Chirdon, which is still running.
Police Office in Spondon – Could there be a set time for an officer to be in the Police office every day. Could there be a letter box available all the time?	<ul> <li>Operation Chirdon was initiated as a result of high volume of reports of burglaries and auto crime offences being made to the police.</li> <li>Police respond that having a set time every day for an officer to be in the Spondon Office is not practical on a number of levels, including: <ul> <li>Ineffective use of officers' time. Having to be in the office every day at a set time restricts officers and the service meaning they would be unable to respond to anything else.</li> <li>Differing shift times - there will not be a set time on the same day(s) every week when someone will be available. Therefore it will be hit and miss, and ultimately lacking in worth.</li> <li>Unsuitable building. The interior has just two rooms, in the first confidential information is kept and in the second is a locker room not suitable for speaking to anybody at length. The access is not Disability Discrimination Act (DDA) compliant.</li> <li>Regarding the letterbox. This is not straightforward. There have been recent discussions over removing the post-box entirely as people put all sorts of unsuitable items in it, including valuable found property. However, the plan is to retain what currently exists with it being accessible only at certain times.</li> </ul> </li> </ul>
Police Officer time on foot - Why do the officers not spend more time on foot?	PC Michelle Azizi explained at the meeting that officers Police Constables (PC) and Police Community Support Officers (PCSO) patrol on foot and by bike but there are situations when the Police will need to respond quickly to incidents using a car depending on what the local circumstances are.  The Police Sergeants will continue to commit the Spondon Safer Neighbourhood Team (SNT) staff to spend some of their duty time on foot or bike patrol in Spondon
Police surgery - What alternatives are being considered to existing	Police recognise that they are not well attended in Spondon or elsewhere. However, the Police have a current commitment countywide to hold a surgery every month at a set time/place. Having

a set time provides stability which would be lost if relied only on ad hoc arrangements around coffee mornings or other similar events. Police would struggle to effectively publicise the surgeries if the structured approach was changed. From experience the Police know when people do attend surgeries it is often to discuss something sensitive or confidential, and many coffee mornings or similar event do not offer a suitable environment. However, the Police do attend a number of such community events in addition to the regular surgeries to make sure a suitable mix of alternatives are available for the local community to engage with and talk to their local Police. The Police are keen to keep the dialogue open on options for new ways to maintain and improve regular communication.

#### **Environment**

Sitwell Street Wall – repairs – a resident asked why the work on the wall along Sitwell Street was taking so long and causing disruption on the footway. When will it be completed? Is the Council paying for the work?

Councillor Berry responded at the meeting that he had concerns about the work being done to the wall and the removal of trees from the garden.

Agreed to get an update from Council officers and to make sure the Council was not covering the costs and that the wall will be replaced.

The latest feedback from Council officers is that:

Part of the wall collapsed in October 2010. The wall forms part of the boundary to land attached to The Homestead on Sitwell Street. The wall is old and has been in poor condition for some time. The Council's and owners immediate concerns following the collapse was the danger to highway users so the Council erected temporary fencing and closed the footpath with signed diversions as a short term measure. The costs will be recharged to the owner. Highway safety is a prime concern however the position is complicated by trees on site being protected, the wall being within a Conservation Area and a potential Planning application. To make the wall safe to highway users, part of it needed taking down to the 'crease line'. The owner has paid for this work'.

The Council's structural engineers advised removal and battering back of the soil to leave the bank at an appropriate angle and until these works are carried the current restrictions on the footpath need to be retained, however, the removal of a horse chestnut tree is needed before the battering works are done. Consent fro the removal of this tree has recently been given and the owner has been requested to proceed with these works as quickly as possible to enable the footpath to be reopened.

Due to safety needs, the 3 lime trees also needed to be removed and appropriate notice was given to the Council.

The Council will require suitable replacement trees in appropriate positions within the site.

Cyclamax Planning Application Appeal – the campaign group established to represent the community at the appeal asked if the Spondon Councillors could attend the enquiry Since the forum meeting in November Cyclamax has withdrawn their appeal and the Public Enquiry has been cancelled. At the forum meeting Councillor Williams had confirmed that she would have attended the enquiry.

### Housing

Craddock Avenue
Development – What is
the latest regarding the
Housing Development.

The development is part of a Housing Private Finance Initiative (PFI) bid to Central Government which, if successful, will provide 55 new homes on the site of the former Derbyshire Blocks on Arnhem Terrace and Craddock Avenue. We are working with Riverside Housing, an established housing provider within Derby, to build and manage the properties which will be built to Lifetime Homes standards.

Early indication is that this project will be supported by the current Government subject to value for money assessments. The team is working towards contractual and financial close. There are some negotiations on-going with the developer partner (Riverside HA), but the essence of the agreement with them is in place already.

This issue had been a local Police priority for 3 months to November. Special visits had taken place by the Police and Derbyshire Fire and Rescue Service to assess and educate local parents and drivers around schools. For example on 8 November the services attended local schools and no issues were identified on West Road and surrounding area. Leaflets were handed out at Asterdale and Borrow Wood schools. At Asterdale school there were instances when officers identified inconsiderate parking -these were staff collecting children from the Children's Centre, taxis and the school minibus. Councillor Williams agreed to contact the local school to inform them. The Police reported that cars which park on the junction or which park across drives could receive a fine for obstruction. It is part of the Highway Code. It is not enforceable by the Councils Civil Enforcement Officers.

While parking problems around schools is no longer a Police priority, other work is being progressed by the Spondon Neighbourhood Board. Additional funding will be provided to the Councils Civil Enforcement Officers to visit Spondon schools. Also, investigations taking place to find ways to reduce the conflict at the junction when the Spondon Flyer buses meet at this point and cannot pass.

Stan Werbinski, the Council Road Safety and Travelwide manager reported at the meeting that reducing car use around schools is the



Oxford Street parking	best sustainable solution. He reminded the meeting that Spondon Neighbourhood Board had funded an education and awareness programme at St Werburghs school which had increased walking to school. Borrow Wood school is also increasing the numbers walking and cycling to school. Stan reported that Spondon ward did not have a high number of casualties linked to children going to and from school, but work was still being encouraged to improve education and awareness.  The forum meeting agreed not to continue this issue as one of the three Police priorities.  Councillor Williams responded that a parking permit scheme had

New families had increased the number of cars and</li> </ul>	been considered previously but it had not been supported by enough residents. Councillor Williams reassured the meeting that the Fire Service has previously confirmed that they would be able to access the top of the street in case of fire to a property. It was noted that the layout of Oxford Street does not offer many feasible options to increase parking for residents.
he was concerned about access for emergency vehicles. Could the bushes be removed on Brunswood park to give parking spaces?	Parks Officers have responded that the principle is not to replace public open space with car parking and converting this public open space into car parking is not supported.
Canal Walkway – repairs – a resident asked what repairs can be done to the canal footpath from B&Q to the wooden bridge. Can it be repaired to be like the part near to the Wimpey Estate?	Derek Hathaway responded at the meeting that as the path is a grassed path it is likely to flood. There are plans to improve this route as part of the Canal development including a two metre wide towpath. It would not be sensible to spend lots of money repairing when massive investment is planned. It was noted the path surface put in by the Wimpey Estate was against any planning requirements.  Streetpride and Parks respond that the path was constructed with a stone base from the A52 by B&Q to a point just east of Anglers Lane by Parks many years ago and has had little maintenance. In response to this request some minor repairs have been completed to fill in some of the main holes along the path. However there is unlikely to be Council money available in the current climate for significant repairs to the surface. The Council is mindful that the Canal Trust is aiming to attract funds to make significant improvements along the canal but as yet no funding is in place.

## Police Safer Neighbourhood Update

### Spondon Safer Neighbourhood Team Policing priorities – November 2010

The Police encourage Spondon residents to attend the Spondon forum meeting to raise the problems that worry them most so that they can be discussed and priorities can be set by the community. The current Police priorities were agreed in November 2010 and this is where the Police have targeted their resources in the following way:

- 1. Vehicle thefts and thefts from vehicle/dwelling burglaries in the Spondon neighbourhood. Actions to be taken are:
- a) Increased high visibility patrols by Police and PCSOs. b) Information given to community to remind to remove valuables from vehicles when un-attended and keep doors/windows secure.
- 2. Anti-social behaviour Arnhem Terrace at 'The Tunnel'. Actions to be taken are:
- a) High visibility patrols in the area by the team. b) Liaison with partner agencies to look at ways of tackling the nuisance behaviour. c) Provide reassurance to the local residents and encourage them to report any suspicious behaviour or individuals.

There will be a chance to review these priorities and identify new priorities at the Spondon Forum on Wednesday 9 March if considered necessary.

## **Police Surgeries**

The Police hold a regular surgery for Spondon residents. This is a confidential service provided by the Police for residents to speak about any issues or problems they may have and to meet the local safer neighbourhood team. They are from 6 to 7pm on the 1<sup>st</sup> Monday of every month at Spondon Library. **Next meeting is on Monday 4 April 2011 from 6 to 7 pm.**

If you want to register for derby homefinder and are not currently a derby homes tenant you will need to contact housing options.

### **Antisocial Behaviour Live Cases**

We currently have fifteen open antisocial behaviour cases in Spondon. The majority of these relate to noise nuisance.

#### **Rent Arrears**

Rent arrears are managed on a patch basis. Spondon and Chaddesden Park's arrears figures are combined. Current arrears performance in this area is 10.87% (£10,032.21) ahead of



target.

## Permit Scheme for Road Works

- Do you have a view on road works and how they are managed?
- Do you know a busy road that needs a permit to control road works?



The City Council is developing a Permit Scheme for additional controls on road works, for some of the busiest roads in the city. The aim is to improve the system for managing works on roads, footways and verges to provide better coordination and planning.

The Council is proposing a scheme under which permits will operate on a limited number of roads. The roads to be included will tend to be the busiest routes in the city including those that lead from residential areas to the major road network, or link local facilities to the main roads or residential areas. For example, in the city centre the main pedestrian areas will also be included.

Currently, utility companies just need to serve the appropriate notice to have rights to carry out work. There is a general duty for those carrying out works to coordinate their activities but the Council has limited powers to enforce this.

If a permit scheme were to be introduced, those wanting to carry out works on selected routes will need to get a permit for the proposed work. The Council will be able to issue a permit with conditions. Anyone working in the road will be required to supply more information than at present and there will be incentives to work with other companies and the Council in order to reduce the impact on road users and pedestrians. The current 'notice' scheme will continue on all other roads in the city.

The scheme requires approval by the Department for Transport – DfT - before it can be implemented, but the Council wants to seek your views on the scheme before details are sent to the DfT.

Maps showing the roads proposed for the scheme will be on display at the Spondon Neighbourhood Forum. Please come along and give us your comments, especially on:

- the roads proposed
- other roads that you think should be considered for inclusion
- why you think they should be included
- other issues specific to the area that you think we need to be aware of when planning and managing future road works

It is not feasible to include all roads in the city. The scheme is focused on improving the management of key roads, preventing an unnecessary burden on utility companies and the Council, and to keep costs at a reasonable level. Proposed roads in the scheme in **Spondon** are:

Borrowash Road, Church Street, Dale Road, Derby Road, Derby Road to A52 slip road, Locko Road (to Sancroft Road), Lodge Lane, Moor Street, Nottingham Road, Raynesway, Sancroft Road, Sandringham Road, Sitwell Street, Stoney Lane, Willowcroft Road.

## Help contribute to the Spondon Neighbourhood Development Plan

- Are you interested in shaping the future (development) of the Spondon neighbourhood?
- Do you have a view on what social, community and cultural facilities are required?
- Do you want to ensure that the Spondon neighbourhood meets the day to day needs of its residents?

If you are, then you will be interested in the Core Strategy which sets out the Council's proposed approach to how the city should develop. It is the most important of the plans the Council will produce as part of the Local Development Framework (LDF) to create planning policy for Derby.

Last year, City Council Planning officers consulted on options for future development in and around the city. At the same time, South Derbyshire District and Amber Valley Borough Councils consulted on similar issues, including new housing areas on the edge of Derby. Since then, all three Councils have decided to take a fresh look at the issues raised and the way we engage with local communities in drawing up our Core Strategies.

The City Council Planning Team will be undertaking on-going engagement with communities prior to drawing up a draft plan for formal consultation. This period of engagement will run through most of 2011. A draft plan will be proposed for consultation in January 2012 and submitted to the Planning Inspectorate for Examination in April 2012.

## The first step will be for Planning officers to attend Spondon Neighbourhood Forum on Wednesday 9 March where they will:

- Explain the Government's approach to planning, including proposals for new Neighbourhood Development Plans produced by communities themselves.
- Explain how we propose to progress the Core Strategy in light of proposed changes to the planning system.
- Ask people to start thinking about their communities; what they think the main planning related issues, needs and opportunities are.
- Invite people to put themselves forward to be part of a sub-group of the Neighbourhood Board to engage on strategic planning issues.

To help this process, officers will make available information sheets, about the Spondon ward, which you can use to help you think about issues in your area. There will also be a questionnaire/response form. These can be taken away, filled in and sent back. These documents will also be available on the Council web site.

Amber Valley and South Derbyshire do not have Neighbourhood Boards and Forums. They are holding a series of advertised drop-in events where people can discuss issues about their communities with planning officers. Some Derby residents may receive letters from those Councils about these events, especially if you wrote to them about last year's options consultation.



## **Spondon Neighbourhood Board**

Spondon Ward has a Neighbourhood Board that consists of the three local ward councillors, local residents, and representatives from local community groups, businesses and public services such as Derby Community Safety Partnership, the Council, the Police, Derby Homes, NHS Derby City and Derbyshire Fire and Rescue Service.

The Neighbourhood Board meets every three months to review actions against local priorities, find ways to tackle local issues and encourage local people to take part in decisions about their lives and communities. The Board aims to improve relationships between Spondon communities and public services. The Board priorities for the next financial year 2011/12 are.

- 1. Improve highways and transport with a focus on reducing heavy goods vehicles, speeding, parking and safety around schools
- 2. Improve Community Engagement and Empowerment in Spondon with a focus on communications
- 3. Support a healthier community with a focus on inequalities and obesity
- 4. Improve community safety with a focus on antisocial behaviour, car crime and fear of crime
- 5. Improve the Environment in Spondon with a focus on climate change, dog mess and litter The Board has identified its two Highways priorities for 2011/12 which are to:
  - Complete investigations and tackle the traffic problems on the ASDA island.
  - Improve parking and road safety at the Glendale Drive/Dale road junction.

Council Cabinet to agree if they are included in the 2011/12 capital programme in March 2011.

## **Spondon Neighbourhood Board aims to:**

- create a vision for Spondon neighbourhood
- set local priorities and plans
- encourage local people to take part in decisions about their lives and the Spondon community
- strengthen the role of the Spondon councillors as community leaders
- create better relationships between the Spondon community and public services
- support public services to work with the Spondon communities.

## At Spondon Neighbourhood Forum, residents can:

- raise local issues and concerns
- identify key priorities for action
- meet and talk to local ward councillors and local services such as the Police
- find out what's happening in Spondon
- meet other residents who care about their neighbourhood

## 2011 Census coming to a Letterbox near you

On 27 March 2011 all residential households in the United Kingdom will be taking part in a census. Since 1801 a day has been chosen every ten years for this purpose (except in 1941 during the Second World War). The census provides an excellent source of information about the population. Census statistics are used to work out what supermarkets sell to keep stocked up with your favourites. Fire brigades and the police use census data to help communities, putting fire alarms and crime prevention measures in specific areas.

The benefits are far reaching. The census statistics also feed into the allocation of funding for local authorities, so it is crucial the population estimate is accurate. When the questionnaire envelope comes through the door you'll easily **recognise it by the purple 2011 Census logo**. Take care of it.

If you want to complete the questionnaire online, your individual internet code is on the front of the questionnaire. If you need help filling it in there is a wide range of help options available (such as language guidance booklets, large print format, Text Relay and census field staff on hand, as well as online help and telephone call centres).
