replant the lost trees with the same species and of an appropriate size. It has been agreed that these are to be planted in close proximity to the removed trees but at a sufficient distance to enable repair works to be carried out to the wall. We understand from the owner that planting is currently in progress.

(2) It is not clear at present in terms of the new application what the owner is likely to propose in terms of repairing the wall. He has however indicated it is their intention to fund the rebuilding of the wall from the receipts derived from the proposed development. It cannot be anticipated at this stage whether the application will merit approval or even if it is approved be implemented. With this in mind officers have been trying to reach agreement with the owner on a scheme for reinstating the wall if the application is not approved or implemented. The owner so far is reluctant to make any commitment pending the submission and determination of the new scheme. In the light of not being able to reach agreement officers are currently considering the options with the view to taking a report to the Planning Control Committee. The intention is to time the report so that it can be considered jointly with any report to the Planning Control Committee however one cannot be held ransom by the other and if the March deadline is passed then an independent report may prove necessary

Beacons for Queens Jubilee – Will the Beacons be lit next year? A Spondon Jubilee Committee has been set up to pull together the many ideas from groups and organisations in Spondon. Spondon Board has provided funding to either purchase a new beacon if the one used at the Millennium is no longer fit for purpose or to be used for gas or other costs.

### Housing

Craddock Avenue
Development – What is
the latest regarding the
Housing Development.

The Arnhem Terrace and Craddock Avenue sites are identified for development as part of the Council's Housing PFI Project. The Project recently received Government approval of it's value for money assessment and has been given agreement to proceed subject to other Government approvals.

The developer, Riverside Housing, has now submitted the planning application to build 55 new homes on the site. Residents are able to view the plans on the Council's online planning register available on <a href="https://www.derby.gov.uk">www.derby.gov.uk</a> or in person at Roman House, Friar Gate, to comment on the proposed development. The application reference number is 02/12/00169.

The Council and Riverside are currently looking at the area of public open space adjacent to the development site to look at alternative uses to benefit residents such as an allotment space.

Huntley Ave Housing Development – has a new Planning Proposal been submitted? Cllr Williams reported at the forum that no new proposal submitted, however some comments had been received objecting to the proposal – not due to be considered until 2012.

Streetpride and Highways



- why has only part of it been resurfaced?	All footways are inspected twice a year to identify priorities for work within the Council core budget. While South Avenue was not a priority for the Council core funding, Spondon Neighbourhood Board made it a local priority after recommendations from the Highways sub group identified it and used £5,000 of its Streetpride Budget to slurry seal some of the footway. Some funding was also used on Chapel Lane. Noted that footway resurfacing is very expensive.

# Police Spondon Safer Neighbourhood Team

The Police encourage Spondon residents to attend the Spondon forum meeting to raise the problems that worry them most so that they can be discussed and priorities can be set by the community. The Police will provide an update on activities at the forum on 7 March:

### In November 2011 you said the Policing priorities in Spondon are:

### 1. Auto crime and dwelling burglaries.

**We did:** During the last few months we have maintained a high level of covert patrols in Spondon including patrolling in the early hours on mountain bikes to catch unsuspecting burglars and auto criminals. This targeted approach by Spondon safer Neighbourhood Team has resulted in three arrests this month for auto crime offences.

### 2. Anti-social behaviour - Chapelside and Sitwell Street.

**We did:** Police have worked alongside the community safety partnership and have installed a anti sit bar outside the funeral parlour, which seems to be detering people from sitting outside. Since November Police have received around 5 calls for service in realtion to ASB

### 3. Anti social behaviour - Nottingham Road/Station Road.

**We did:** Police continue to patrol the area both in the day and during the evening. Calls for service are low with approx 3 calls received in January and another 3 in February which has been in relation to ASB.

**Police Surgeries** - a confidential service for residents to speak about any issues or problems with Spondon Safer neighbourhood team. From 5pm to 7pm on the 1<sup>st</sup> Monday of every month at Spondon Library. **Next meeting is on Monday 5 March 5pm to 7pm.**

#### **Anti-Social Behaviour in General**

ASB in general is low in Spondon. In February Spondon SNT made 8 referrals to the Anti Social Behaviour team. In the last three months Spondon SNT made 22 referrals.

The figures show a 82 crimes occurred in Spondon during the month of January 2012 Criminal damage has offences have seen an increase from 9 to 14 compared to this time last year. To date 18 crimes dealt with by way of positive outcome

### **Events/Operations:-**

Operation Chirdon continues in Spondon to tackle auto crime with high visibility deterrent patrols and covert patrols to detect and arrest offenders. We also have high visibility patrols from Derby section. Officers out and about in Spondon in the early hours, targeting auto crime and burglary hotspots, as well as other covert tactics to catch unsuspecting criminals in the act of committing offences. This has included patrolling Spondon on mountain bikes in the early hours as we are determined to catch criminals in the act.

PC Price is undertaking a CCTV mapping project - he is carrying out high visibility foot patrols all over Spondon, identifying domestic and business CCTV locations and compiling a database of these places, and people to contact. The reason for this is to utilise resources that are already available in the community to help identify offenders quickly, taking them off the street.

# **Activities and Services for Older People**

# **Adult Social Care in Derby – Your Life Your Choice**

Changes are taking place in Adult Social care to give people who need support more choice and control.

**Self Directed Support** is the new way Derby City Council provides adult social care. If you qualify for support from us, you can choose and control how you want your support to be provided, paid for by a personal budget

By using a **Personal Budget** people will be able to plan and buy the kind of support they need to suit their own lifestyle, circumstances and hopes for the future. Instead of people getting standard contracted services people will be able to decide how their own support is delivered using a range of different providers and services.

### How is Adult Social Care supporting these changes?

Better information and advice about choices is being developed. This will also be available to people who fund their own care so they are better informed. A new web portal is being produced to provide up to date, consistent and accurate information which is easy to find. An up to date directory of services is also being prepared.

This new way of working needs new services to be in place. A Market Development Manager is working to help develop the local market for services to people with adult social care needs. This will help providers be more efficient and make costs competitive. We are encouraging the development of local community based service providers. We have also developed a register of Personal Assistants which people who have care needs can search to see if someone meets their particular needs.

A quality assurance framework is being developed to give people confidence in the services they are buying and to ensure standards of service are maintained.

Work is also on-going with Adult Learning, Leisure and Transport Department to ensure their services are appropriate to older people's needs.

# **Supported Living Service – Derby Homes**

Delivered through Derby Homes, the service provides housing related support to people living in Derby (aged over 60 and/or in receipt of disability allowance) to enable them to live independently in their homes. Our Support Officers visit on a regular but flexible basis, depending on the needs of our clients. During these visits, we work with our clients to develop a support plan and provide a package of support aimed at maintaining independence.

As part of the Supported Living Service we can also provide a 24 hour connection to the CareLink alarm service through an easy to use intercom/call system. CareLink is our emergency call centre and is open 24 hours a day, 365 days a year. This means help is always close by. (To be connected to Carelink the client must provide a landline in their property).

### We provide this service to:

- make sure the client receives the right support and care to help them stay independent by working with other agencies such as social care and health providers.
- help the client stay in their home and get involved in local community or other activities if they want to.
- agree an appropriate and flexible support plan aimed at increasing or maintaining independence.
- provide a quality service with well trained and professional support staff.
- continuously improve the service by consulting with our clients and stakeholders.

The Supported Living Service is currently oversubscribed and we have therefore implemented a waiting list.

Making Space aim to do whatever they can to reach people experiencing memory problems and their carers and to engage them in accessing support..

The Spondon Carers Group has been meeting at Spondon Village Hall, Sitwell Street, on the fourth Friday of the month from 1.30 pm – 3.30 pm. Next meeting is on 23 March However, Making Space is currently reviewing all the cafes and groups and those under utilised could be disbanded

# Dial a Bus Service to Local Supermarket

You may be aware that the Council decided to extend the Dial a Bus Service to local supermarkets for as long as possible, to allow users to find alternative transport. However, this service will stop with effect from 31 March 2012, as there is no further budget available. Three companies have shown a willingness to provide an alternative service for you. If you would like further information, please contact them on the numbers shown.

- 1. Swift Cabs have dedicated a telephone number 01332 367655 for passengers to prebook a journey and they aim to place two or three passengers from a local area into one cab and therefore be able to keep their price down.
- 2. Western Car Company Ltd is also aiming to provide a shared car, door to door service. You can contact them on Derby 331331.
- 3. RK Travel is providing a shared weekly bus which will take a number of booked passengers from their home to the Spot & back. Contact them on Derby 762703.

Derby Shopmobility is also available for anyone with mobility problems. Their joining fee is currently £10 for life, with a small charge for hiring their vehicles. # **Derby's Core Strategy -** Consultation about Parking Policies, Out of Centre Shopping and Public Open Spaces

In 2009, the Council started to develop its Core Strategy. The Core Strategy sets out a vision for what Derby will be like by 2028 and how this vision can become a reality.

The Core Strategy will identify where major changes will take place and set out policies that will guide the type, amount and quality of development across the City. As part of this we have been consulting residents on a number of subjects. The last consultation was on housing growth in the city and a summary of the responses can be found on the Local Development Framework webpage. To help us develop our planning policies for the City, we need your views on three specific areas of planning policy. These are:

- Parking standards
- Public open space standards
- Out-of-centre shopping

We want you views on things such as the amount of parking made available with new development, whether there are different ways of providing open space through new development and the role of out-of-centre shops and how they could trade in the future. Your views will help us decide if the current policies are still appropriate or whether new approaches are needed.

Consultation will continue until **26 March 2012**. The results of the consultation will help us in drawing up our detailed policies.

Alongside the consultation, the Council has also published a Brownfield Housing Land Regeneration Statement. The last Core Strategy consultation gave a strong indication that the public wants the Council to maximise the amount of development that takes place on 'brownfield land" and filling empty homes. This document sets out the action the Council is currently taking to achieve this goal and the contribution that we expect such sites to make to meet our housing needs.



# **Environmental Enforcement Response Service**

The Council has launched a new Environmental Enforcement Response Service, it was set up in October 2011 to tackle environmental crime such as fly tipping, dog fouling, fly posting, graffiti and littering. Six officers patrol the city, investigate offences and take enforcement action including fixed penalty notices and court prosecutions. They are also out at night from Thursday to Saturday to 1.30am and Sunday to 12 midnight to investigate noise and bonfire nuisance.

The team is keen to get information and evidence from residents to allow action to be taken against offenders. If you have evidence, please contact the service on 01332 642020.

While a lot of the teams time is spent responding to dog fouling and flytipping, (see posters below) one area of work tackled by the Team is Fly Posting. Often not fully understood, Flyposting is an offence under the Highways Act 1980 and Town and Country Planning Act 1990. **What is Fly-posting? -** Fly-posting is an illegal activity. There is no formal definition of flyposting. However, it is generally taken to be the display of advertising material on buildings and street furniture without the consent of the owner

**The law -** It is an offence under the Highways Act 1980 to fix items on the public highway or on any highway structure and the Council is able to remove such items without notice Anyone found to be fly posting will be issued with a fixed penalty notice of £75 or prosecuted which can result in a fine up to £2500

Unauthorised advertising also contravenes the Town and Country Planning Act 1990. Where an offence is proven the contravener shall be liable on summary conviction to a fine, currently not exceeding £1,000 and, in the case of a continuing offence, £100 for each day during which the offence continues after conviction. This provision applies to all types of unauthorised advertisement and not exclusively to fly-posting

**Your responsibility** - We wish to make sure that businesses and the public are aware of their responsibilities so that they do not fall victim to the legislation. The Council will not hesitate to take formal proceedings against those who flaunt the law and evidence is provided. For more information contact the Environmental Protection team:

# **Mary Portas Pilots funding**


At the Spondon Board meeting on 22 February the Board agreed its priorities for next year and considered areas to focus on (see page 17). The Board agreed a new priority to **Create a thriving and vibrant Spondon**. The Board also agreed to set up a new sub group to lead on this priority - while a name has still to be agreed it's currently being called *Spondon Village Innovation Management Association*.

This sub group, while in early stages, has quickly had discussions with Spondon Traders Association and Spondon Community Association and is looking at an opportunity to apply for funding from the Mary Portas Pilot fund to look at ways to improve, develop, sustain the Village Centre as a place to visit and shop.

# **Speed Indicator Device (SID)**

The Board has funded a Speed Indicator Device (SID) for use in Spondon. The device shows drivers the speed they are travelling and responds with a Thank You if the speed is within the speed limit. The Board is keen to educate and change the behaviour of inconsiderate drivers. The first location was on Locko Road and is now on Moor Street. Information about the impact of the SID and vehicle speeds will be presented to Spondon Board.





# **Spondon Young Team of the Year Award 2011/12**

This award sponsored by Spondon Neighbourhood Board is to recognise, reward, promote and celebrate the achievements and successes of young people from Spondon who are taking part in team activities – whether in a sporting team or another team such as music or dance The awards will be announced in April/May 2012.

**Nominations by 31 March 2012** are welcomed from Clubs, schools and organisations with a base in Spondon that run teams for young people up to and including 19 years old that live in Spondon. Clubs based in Spondon but with members who live outside can be nominated. Teams that are nominated will have achieved at least one of the following:

- provided the young people with a positive activity or
- > involved the young people in a new experience or
- given the young people a sense of achievement or
- > made an outstanding contribution to their club or
- > achieved outstanding success or
- > inspired the young people for the future adding to their learning and development.

# Safer Spondon - SmartWater Project

SmartWater is liquid that contains a unique code which can be read under ultraviolet light. When applied to valuable items the unique code can be identified by the Police so that if they are stolen and later seized by the police, their original owner can be traced.

Safer Spondon is running this project. The group aims to make Spondon a safer place to live by preventing and reducing crime and the fear of crime for residents and traders in Spondon. With funding from Spondon Neighbourhood Board Safer Spondon is working with Spondon Neighbourhood Watch groups and the Police Safer Neighbourhood Team to deliver the project.

SmartWater is now being made available to Spondon residents at a competitive price of £20. The project aims to be sustainable but affordable. After the launch at the Spondon Neighbourhood watch meeting initial sales have been very encouraging

# Footpath Improvements on Spondon Linear park – Canal Walkway

Spondon Neighbourhood Board has been working with Derby Parks Management Team to improve the footpath along the canal walkway in Spondon linear park

The footpath is being improved from Megaloughton Lane to Anglers lane and will be completed by the end of March.

The new footway is constructed of recycled products which have been used on other cycleway/pedestrian routes in Derbyshire.

The Canal Trust has been involved in the planning of the work and have been particularly supportive of the designs to be included at the access points at Station Road and Anglers Lane. The railings will incorporate a canal barge in their design as shown here.



# **Making Improvements to Dale Park**

Spondon Community Association, Village Improvement Committee (VIC) and Derby Parks Management Team are working together to deliver a series of improvements to Dale Park. The initial proposals were developed by the VIC with Groundwork Derby and Derbyshire during 2010 and 2011.

While some details are still being finalised the initial work being proposed in phase 1 before the end of March includes:

- Re-surface about 200m of existing footpath from the Park entrance to the access off Holyrood Close.
- Repair or replace the height barrier to the Park entrance
- Consider removing (and reusing?) the bollards and making good in the car park
- Provide Picnic tables
- Refurbish seats
- Clear and tidy the car park

The second phase of improvements will be developed during the year ahead

Particular thanks need to be expressed to Spondon Village Improvement Committee for the work already done to get the proposals this far.

# **Funding Opportunity for Community Buildings**

Western Power Distribution (WPD) have just launched their Community Chest grant scheme, and
